The money raised by Wellbeing of Women is invested in medical research, development and training of specialist doctors, many of whom go on to work in other countries, and the provision of top quality information about obstetrics and gynaecology to women (and men).

Wellbeing of Women is affiliated with the White Ribbon Alliance, an international coalition devoted to safe pregnancy and childbirth in developing, as well as developed, countries.

One of the research projects currently supported by WOW:

"The Release Trial"

A randomised trial of umbilical vein oxytocin versus placebo for the treatment of retained placenta

This project is led by Dr. Andrew Weeks of Liverpool Women's Hospital.

Retained placenta affects between 0.5 and 2% of all women after delivery (1 in 50 women) and is a major cause of post partum morbidity in the UK. The standard treatment is to manually remove the retained placenta from the womb under anaesthetic. This requires admittance to hospital with operating theatre facilities and in remote parts of the developing world, where there are no theatre facilities, 10% of women will die whilst trying to reach hospital.

The project will trial the use of a simple injection of oxytocin into the placenta, through the cut umbilical cord. This is a low cost medical intervention and if proved effective could be administered in a far wider range of settings.

The trial involves 5 UK centres funded by WoW, and also 6 sites in Uganda, funded by WHO, and 3 in Pakistan funded by Higher Education Commission for Pakistan. It is fair to say that the WoW funding was crucial in this trial going ahead.

The outcome could have an immediate effect on reducing maternal mortality as a result of retained placenta. This would make a difference in every country in the world but be particularly effective in the developing world.

Money raised will go towards this project and other vital research.

SPEAKER BIOGRAPHIES

Liz Campbell began her career as an HR professional in the construction industry.

After starting her family she also started an industrial employment agency with two partners to enable her to work flexibly whilst bringing up her children.

In 1997 Liz sold her share in the business and began a decade of work in the public sector as a non- executive director in two NHS trusts and an Independent member, vice chairman and chairman of a police authority.

Liz has held national portfolios for policing and contributed to changes in policy in some key areas of police reform. At the same time Liz has been a volunteer with several charities both as a fundraiser and as a trustee.



Professor Lesley Regan graduated from the Royal Free Hospital in 1980. Her first registrar post was at Addenbrookes Hospital, Cambridge where she became interested in the causes of miscarriage.

She heads the Department of Obstetrics & Gynaecology and is Director of the Recurrent Miscarriage Service at St Mary's Hospital, Imperial

College and Visiting Professor at Harvard Centre of Excellence for Women's Health. Her primary research interests encompass recurrent miscarriage and infertility.

In 2005 she received a "Women of Achievement Award" for her outstanding contribution to medicine.

Lesley has written two best sellers: Miscarriage —what every woman needs to know; published by Orion 2001. Your Pregnancy Week by Week; published by Dorling Kindersley in 2005 has now been translated into seven languages.
