MESSAGE FROM HRH The Duchess of Cambridge



I am delighted to be here this evening to hear once again about the wonderful work that 100 Women in Finance does for so many good causes.

I am particularly excited that this past year you have chosen The Royal Foundation as your UK Charity of the Year. This means a great deal to me, especially because you are focussing your fundraising on supporting schools and their efforts to improve children's mental health.

Through my own work in this area, focussing on the youngest children, their parents and families, I continually meet experts who tell me the same thing: that so many of the problems adults face in their lives can be traced back to challenges in their earliest years. The evidence is clear - the first few years of a child's life are more pivotal for development, and future health and happiness, than any other single moment of our lifetime.

But it's also clear to me that in these first years, children need the right support from all those charged with their care. Teachers and school staff have a critical role to play here, but they have not always been able to gain access to the right range of advice to help their young students as they would wish.

For this reason, The Royal Foundation has led a collaborative programme to develop an online resource for primary schools in the UK to provide accessible, up-to-date, quality-assured information to help guide teachers in their efforts to support the mental health and emotional wellbeing of children in their schools. The money that you have so generously raised during the last year, and that you will raise tonight, will help towards our Mentally Healthy Schools Programme as it is further developed in the coming year.

We have found through our work with The Royal Foundation that when people come together, they can achieve great things to tackle some of today's biggest challenges. Your good faith in working with us to support the mental health of the youngest pupils in schools is a wonderful example of that philosophy.

**Director, London School of Economics
and Political Science**



Dame Minouche Shafik is a leading economist, whose career has straddled public policy and academia. She was appointed Director of the London School of Economics and Political Science as of 1 September 2017.

She trained as an economist, studying at the University of Massachusetts-Amherst, the LSE and the University of Oxford and, by the age of 36, had become the youngest ever Vice President of the World Bank. She later served as the Permanent Secretary of the Department for International Development from 2008 to 2011, Deputy Managing Director of the International Monetary Fund and as Deputy Governor of the Bank of England from 2014-2017, where she was responsible for a balance sheet of over £500 billion.

Reflecting its reputation as the world's greatest museum of art and design, the Victoria and Albert Museum's magnificent South Kensington building is a unique gem of Victorian architecture. A treasure house of amazing and beautiful objects with collections of fabulous scope, astonishing richness and diversity that spans two thousand years and incorporates objects in virtually every medium and from many cultures, the V&A is an unrivalled repository of some of the best examples of mankind's creativity. The Museum was established in 1852, following the enormous success of the Great Exhibition the previous year and moved to its present site in 1857. In 1899, Queen Victoria laid the foundation stone of a new building designed to give the Museum a grand façade and main entrance. To mark the occasion, it was renamed the Victoria and Albert Museum in memory of the enthusiastic support Prince Albert had given to its foundation. Henry Cole, the V&A's first director, declared that the Museum should be a 'schoolroom for everyone'. The V&A today offers visitors the chance to explore and discover many delights.

In a speech at the launch of the new website, Her Royal Highness said: "I see time and time again that there is so much to be gained from taking the mental health of our children as seriously as we do their physical health. When we intervene early in life, we help avoid problems that are much more challenging to address in adulthood. My own commitment is to the youngest and most vulnerable in their early years - babies, toddlers and school-children - and to supporting all those who care for them."

Support from 100 Women in Finance is particularly supporting Mentally Healthy Schools. Research shows that one in ten children will experience a mental health issue at least once before age 11 and many adults with lifetime mental health issues can trace their symptoms back to childhood. It is clear that addressing mental health at an early age and within the confines of schools is an unparalleled opportunity to get help to those who need it at a point when early intervention could be most effective.
