2023 started off with a bang as our volunteer committees produced over 40+ in-person events within our three pillars across the globe. JumpStart Day Hong Kong kicked off on February 2nd.

Earlier this month, Amanda Pullinger, 100WF CEO, and Amy Flikerski, 100WF Board member, participated in the iConnections Global Alts 2023 conference, in Miami, as panel speakers. iConnections Global Alts 2023 is a landmark event, held annually and welcoming nearly 3500 guests, including over 1000 of the world's leading allocators and more than 700 funds. 100WFinTech held a panel discussion at the London Plato FinTech Conference where the panelists, moderated by Kenzy Goodwin, Chair of 100WFinTech Global Visibility Initiative, engaged in a lively discussion of how traditional financial institutions are engaging with digital assets. Speakers included Monica Summerville, Head of Capital Markets Technology Research at Celent, Oliver Wyman, Jie Wu Latham, Partner at 01 Capital Boutique Investment Bank, Helen Disney, Director of The Realization Group and Founder of Unblocked, and Jennifer Keser, Head of Regulation and Market Structure at TradeWeb, navigated the audience through what digital assets were, the practical applications of blockchain technology within TradFi organizations and the benefits and challenges of these practical applications. The reality of the regulation arbitrage threat and the necessity of interoperability were made clear and we also dissected the impact ESG had within cryptocurrency. The panel concluded the conversation with their thoughts on what to expect in 2023 and listed a number of government consultation processes with the industry. The Question and Answer discussion focused on CBDCs (particularly Bank of England plans) and the positive and negative impact that innovation can have on existing businesses.





On February 1, the 100WF New York Risk Peer Advisory Group produced a webinar on the macroeconomic and political outlook for 2023. Speakers for this online event included Dr. Alexis Crow, Global Head of Geopolitical Investing at PwC and Tatiana Segal, Global Head of Risk and Analysis at Morgan Stanley, who also moderated the session. Current global events, how they have had an impact on the financial industry, and how they might affect investments and economic activity over the next few months were considered. On February 3, the Early Career and MidCareer Hong Kong committee produced the event, "Crafting a New Career Vision," and Wellington Management Hong Kong hosted the in-person event in their office. Maria Clancy, licensed career coach and accredited Design Your Life practitioner at Disegno.life, discussed her approach to assisting women to create their own personalized Career and Life Design. She shared how the process of prototyping and learning through action, plus reflecting on past and current narratives will lead you to arrive at a blueprint for a revitalized plan. On February 2, 100WF rolled out another hybrid Regional JumpStart Program in Hong Kong, generously hosted by UBS. Over 60 university-aged students joined to explore different aspects of the financial services industry. Speakers shared insights and trends in finance followed by speed mentorship where over 30 seasoned professionals interacted with students.

On February 21, a well-attended 100WF Inaugural Cayman First Impressions Dinner took place at the Ritz-Carlton, Grand Cayman. Senior industry professionals and the young women in their lives (daughters, nieces, mentees and others) were invited to listen to a panel of inspiring female finance professionals and meet with these role models over dinner. HRH The Countess of Wessex, 100WF Global Ambassador, was among one of our special guests. The hope is that by giving students, including 100WF GirlForce100 mentees, an insight into different career opportunities and pathways within the industry, they will be inspired to forge their own careers in finance.
