What's New at 100WF?

Our volunteer committees organized more than 30 in-person events globally across our three pillars in April, bringing our year-to-date total to 104. A highlight for the month was the official launch of our Nigeria location, which was attended in-person by 100WF CEO Amanda Pullinger.

The application process is open for our APAC and Americas DEI Awards, which will be awarded at our Hong Kong and New York galas, respectively. The eligibility requirements for the APAC have recently undergone revisions, with modifications made to the criteria for minimum employees. The new minimum threshold of 30 employees is more reflective of the APAC market landscape. Applications will be accepted through June 30, 2023.

Our Impact Investing Symposium (IIS), previously run under the non-profit High Water Women (HWW), is happening in New York City and we've shared the Save the Date with 100WF members and a select group of attendees who have participated in this event historically. NIGERIA LAUNCH EVENTS

100WF marked the official launch of its Nigeria location this week with keynote speakers Sola David-Borha, former CEO of Standard Bank Group, Africa Region, and 100WF CEO Amanda Pullinger, addressing senior leaders in the financial services sector in Nigeria and 100WF member at a dinner sponsored by First Bank of Nigeria, Verod Capital, Citi, and Stanbic IBTC. Amanda, Nigeria Committee members and Nigerian Exchange Group executives also commemorated the launch with the NGX closing gong ceremony. Other events, organized by the 100WF Nigeria Committee, included a roundtable meet and greet session hosted by FirstBank and a cocktail reception hosted by Verod Capital which featured remarks by MOFI. Ending the week was a fintech-focused breakfast session organized by 100WFintech Visibility Committee.

SEC WEBINAR NEW YORK

On April 25, Bonnie Sussman, Partner at EisnerAmper and 100WF MidCareer New York Committee member, held a webinar on SEC enforcement priorities & future policies, with over 270 registrations from our membership. SEC representatives, Antonia M. Apps and Maurya Crawford Keating were keynote speakers. Bonnie moderated topics ranging from identifying conflicts of interest, to ESG-related disclosures, guarding data, responding to malicious incidents, and advisor focus areas. The webinar provided valuable insight on SEC policies, compliance obligations and operational risk management for private funds.

AMERICAS

100WF Toronto members gathered on March 28 for an interactive conversation produced by the Toronto education committee and hosted by Fitch Ratings at the National Club. Panel speakers included Sarah Keyes, FCPA, FCA, CEO at ESG Global Advisors, and Tamara Tisminetzky, Director of ESG Research, Sustainable Finance at Fitch. Sarah and Tamara discussed recent updates on ESG and Canada's Nuclear Power Strategy. They reflected on the social license to develop support for the government's nuclear power strategy as well as what lies ahead and the risks and opportunities faced by both issuers and investors.

On April 12, the New York education committee hosted their third in-person event of the year, which was graciously hosted by Natixis. The 100WF members in attendance were treated to an insightful panel discussion, titled "Focus on Real Assets: Aviation, Infrastructure and Electrofuels." Led by Moderator Jérôme Le Jamte of Natixis Corporate & Investment Bank (CIB) for the Americas, panelists Ravina Advani of BNP Paribas, Ayesha Choudhury of Infinium, and Yevgeniya Levitin of Natixis Corporate & Investment Banking, discussed the current trends, risks, and opportunities influencing infrastructure, electrofuels, and aviation investing. Following the panel discussion, members mingled over drinks and hors d'oeuvres, making it a wonderful evening of learning, networking, and connection.

On April 18, the Salt Lake City education committee produced an in-person event "Expanding Women's Access to Capital" hosted by Tanner LLC and SheMoney. Jacki Zehner of ShePlace/SheMoney moderated a panel discussion on how expanding access to capital for women leads to greater economic expansion and opportunity. Panel speakers included: Jacquelynne Elliot, Silicon Valley Bank; Kat Kennedy, Kickstart; Rachelle Morris, RevRoad Capita; and Christina Qi, Databento. Among other insights shared by the panel, the discussion explored how to empower women on both the demand and supply side of capital. The event concluded with the Salt Lake City committee outlining the benefits of a 100WF membership to newcomers and outlined the upcoming 2023 programs planned for Utah's registered members. Following the event, members and their guests were invited to continue the conversation and network with colleagues over refreshments.

EMEA

Swiss pension funds must maintain inclusivity, with non-discriminatory rules. However, payment parity isn't always guaranteed. On March 6, the Geneva education committee produced an event reviewing how employers are addressing gender equality. The event was generously hosted by Centre Patronal. Isabelle Cohen Solal, COHerence&SOLutions, moderated the panel which included Sophie Cathala, Pension Fund Director at CICR, and Brenda Duruz-McEvoy, Head of Social Policy at Centre Patronal. At the event, 100WF members learned about driving change and the view of pension fund managers on the gender pay gap. Following the event, participants were encouraged to keep the conversation flowing and express their viewpoints on the topic, all while mingling and enjoying refreshments with their peers.



The healthcare industry is innovating at a rapid pace, creating a need for capital to fuel growth and investment returns. On March 29, the London education committee produced an engaging panel discussion hosted by Norges Bank Investment Management which was moderated by Sasha Trower, Partner at VenrexExpansion, around the drivers of this need in the healthcare investing arena. Specific areas of focus included augmented computing power, novel patient treatment approaches and a better understanding of diseases. 100WF members got an in-depth overview and understanding of the industry's landscape from panel speakers Bjørg Bakke, Analyst of Healthcare Equity Strategies at Norges Bank Investment Management, Joanne Bugg CFA PhD, Investment Manager at Wellcome Trust, and Michelle Ross, Chief Investment Officer & Managing Partner at StemPoint Capital. Following the discussion, members had the opportunity to share their perspective with peers as they networked over refreshments.

On April 13, the Milan education committee produced an in-person event, "Analyze and Improve the Gender Pay Gap," hosted by PwC. Governments across Europe are prioritizing gender equality by tackling pay gaps between men and women. Similarly, businesses are adopting diversity and inclusion strategies to promote and retain talent. 100WF members and their guests filled the room to hear panel speakers discuss best practices and lessons learned. Panel speakers included: Paola Barazzetta, Partner, Corporate & Compliance, PwC TLS Avvocati e Commercialisti - PwC Diversity & Inclusion Leader, PwC: Licia Ciocca. Human Resources - Inclusion Diversity & Social at Banco BPM; Tania Giallatini, Head of Executive Management and People Acquisition



at Poste Italiane; Anna Chiara Lucchini, Group Head of Leadership Development & Group Academy at Assicurazioni Generali SpA; and Francesco Pasquale De Mutiis, Director at PwC. Following the event members and guests were invited to continue the conversations, share perspectives, and network over refreshments.

On April 18, the Germany committee produced a webinar, "Opportunities and Challenges of Investing in Private Debt," sponsored by ICG and HPS. Over 100 members tuned in to discover the unique features of private debt. Julia Beinker, Managing Director at ICG, gave the introduction and Olga Braun-Cangl, Senior Investment Director at Cambridge Associates, moderated the discussion. Panel speakers included: Roisin Conran, Managing Director at HPS Investment Partners, Sina Timm, Private Debt Lead at Viridium Group, Hannah Wilcock, Associate Director, Marketing and Client Relations at ICG, and Celine Zissel, Senior Investment Manager at Allianz Investment Management. The panel shared their insights as to why investors and asset managers find private debt so interesting, despite market volatility and rising interest rates.

APAC

On April 20, the Singapore education committee produced a sold out event titled "IWD Speed Networking" hosted by Saxo Markets. Inspired by speed dating, the format encouraged guests to interact and connect with as many peers as possible. The International Women's Day celebration encourages both men and women to support each other in advancing women's careers. In these small group discussions participants gained insights as they discussed tips for closing the gender gap in the financial industry. Additionally, members and their guests networked with drinks and bites while sharing anecdotes of success and strategies for empowering women at every career stage!



On April 26, the India Working Group organized and produced a webinar "Gold as a Strategic Asset Class," sponsored by World Gold Council. Gold, a valuable commodity throughout history, makes for a sought-after investment option due to its unique properties. Amidst unpredictable economic conditions like the COVID-19 pandemic, investors are diversifying with strategic asset allocation. Jyoti Rai, 100WF India Working Group Lead moderated an engaging discussion with panel speakers Juan Carlos Artigas, Global Head of Research at World Gold Council, and Bekxy Kuriakose, Head Academics at OAWA about how gold investment has gained popularity as a safeguard against inflation.
