The panel featured speakers, including Barbara Boos (Niendorf Climate Finance), Elvira Lefting (Finance in Motion), Lilly Murmann (SVM Verwaltungsgesellschaft mbH), and Isabel Reuss (Italian Sustainable Investment Forum). Together, they tackled crucial questions about clients, firms, and portfolios, exploring which asset classes demonstrate the greatest efficiency compared to more liquid assets. Moderated by Barbara Wokurka from FINVIA Family Office GmbH and Beatrix Anton-Groenemeyer from Enactus e.V, the conversation delved into how impact is measured and the necessary prerequisites for achieving satisfactory returns alongside a positive impact.





On October 10, members gathered in Paris for an event titled "Europe vs the US: Who Will Lead the Race for Sustainability?" The event, organized by the Paris committee and hosted by S&P Global, highlighted Europe's long-standing position as a pioneer in sustainability, driven by regulatory frameworks and initiatives like the Green Deal. Key participants included Samira Boussem from Flexstone Partners, Sébastien Mandron from Worldline Global, David Vaillant from BNP Paribas Asset Management, with Alexandra Dimitrijevic from S&P Global Ratings, moderating the discussion. The dialogue explored the differing approaches to sustainability assessment across the Atlantic, with a focus on how investment strategies are evolving in response to these challenges.

Hosted by the Bank of Singapore, the session welcomed industry experts Dominique Rose Van-Winther from Final Upgrade AI and Eli Lee from the Bank of Singapore as speakers. A key highlight of the speaking points was the discussion regarding AI applications in diverse areas like writing, financial analysis, and business management.

FINTECH

On October 17 in London, SteelEye hosted an event organized by the 100WFinTech committee titled "Combating Compliance Fatigue in Communications Surveillance." The session addressed the increasing challenges faced by surveillance teams due to the surge in data, complexities in communications and voice monitoring, and overwhelming alert volumes. The speaker panel included Michal Bussi (CME Group), Sophie Dupre-Echeverria (GIB Asset Management), Chiara Sansone (BNY), and Seleema Zhitija (Maniyar Capital). The discussion, moderated by Emmy Granström (SteelEye), explored how compliance teams manage the pressures from massive data volumes and evolving communication methods. Additionally, the role of AI and other technologies in alleviating compliance fatigue and enhancing overall efficiency was emphasized.





On October 21 in London, 100 Women in Finance, through its visibility initiative 100WFinTech, served as an Event Partner for the Plato Fintech Summit 2024. This premier conference concentrated on the intersection of financial services and technology for market participants. 100WFinTech organized an Al panel sponsored by Intelligent Cross, featuring panelists: Rebecca Healey, Founder of Redlap Consulting; Maddy Davies, Equity Trader at Liontrust; Laetitia Visconti; and Rachel Przybylski, Chief Product Officer at Sigma Financial Al. The session was moderated by Scott Graczyk, Head of Business Development at Intelligent Cross. The discussion centered on the impact of Al in financial markets, particularly in execution, drawing inspiration from the research report titled "Al; Beyond the Hyperbole."
